## Music and the hymnals

- Church Publishing is able to grant permission to stream a selection of hymns during the Easter season. See the full list of hymns <a href="here">here</a>. For all other hymns, please contact the copyright holders for each hymn or secure a streaming service license from <a href="One License">One License</a>. Copyright holders for each hymn may be found in the back of each hymnal.
- We cannot give permission on those hymns for which we do not own copyright. Please check with the rights holders or One License. (A full list of copyright owners may be found in the back of *Hymnal 82* beginning on page 930; for *Wonder, Love, and Praise* on page 243, and at the bottom of each page in *Lift Every Voice and Sing II*)
- Subscriptions are available to *RiteSong* with permission to use all material available through the program. Please note that this permission is for bulletin creation and not music streaming. Likewise, subscriptions to the deluxe version of *RitePlanning* include permission for hymns and other music to be reproduced for use in a bulletin or service leaflet but does not offer permission for music streaming.

## Church Publishing Incorporated books

Should you wish to read via video or social media a children's book published by CPI, we ask that you contact us at <u>CPIrights@cpg.org</u> to make an official request. Once permission is granted, these guidelines should be followed:

- All postings or videos include a note that they are being shared with permission from Church Publishing Incorporated and that any post or video be removed after a period of three weeks.
- All posts or videos should include the name of the book or other resource, the author's (and illustrator, where appropriate) name, and mention of CPI as the publisher of the material.
- Authors and illustrators may read or share their own work, as long as they've received permission from a co-creator. Please inform us when you do this so we can keep track of what is being shared where.
- Teachers, librarians, parish formation staff and clergy who intend to make use of such permission email their name, contact information, and the title and author / illustrator of the books they intend to use to <a href="mailto:CPIrights@cpg.org">CPIrights@cpg.org</a> to begin the process.

## Godly Play

Godly Play and Church Publishing Incorporated reserve all rights in the intellectual property contained in the Godly Play materials.

We ask that anyone creating or sharing a video abide by the following:

- At the beginning of the video recording, please state the name of the story and the publisher in the video and note that the material is under copyright and owned by Godly Play.
- Limit the audience in some way. For example, if you use YouTube, please <u>follow these instructions</u> to designate your video as "Unlisted" and only share the link with a limited audience. If you use Facebook Live, please only share within a private group or church page.
- Please remove each video after a three-week period.
